# We need your help, now more than ever

# Thank you for helping us continue critical services through the pandemic

Operating an agency for more than four decades has taught our team of nearly 80 about resilience, adversity, creativity and grace. Never has this been more apparent than the past eight months. With your help, our team has been able to remain flexible to accommodate the latest change or challenge initiated by a worldwide pandemic that has impacted many.

Thanks to the kindness of our donors and volunteers as well as the flexibility of our partners, we've been able to adjust the way we deliver our services. These modifications have enabled us to adapt to social distancing and virtual preferences as well as consider the health and safety of visitors and staff, while continuing to respond to critical safety and emergency needs of our clients.

#### Your kindness will last forever

This year, in addition to compressed violence, our clients are experiencing economic strife like no other time. They are reaching our doorstep with compounded issues of how to make rent payments while also needing assistance for basic needs such as gas or bus tickets and food. Our shelter stays, for instance, are up 35 percent since this time last year. New clients in our Light of Hope program, who often benefit from advocacy and therapy services, are up 3 percent from last year.

If you're one of the donors or volunteers who've raised your hand in support of the nearly 3,000 clients we'll serve this year, thank you! If you've considered giving, we are grateful for every dollar you can share. Your kindness will have lasting impacts on two generations.



# Families are at breaking point

The COVID-19 pandemic has brought many of the families we serve deeper into poverty, at the brink of homelessness. The trends we see are concerning.

- ESCALATING VIOLENCE: Clients have survived more violent assaults with severe injuries. Calls for protection orders are increasing, and sexual assaults are up 11%, with 119 people served in the first three quarters of this year.
- POVERTY & HOMELESSNESS: More clients have lost jobs and are on the verge of eviction, with no place to go. We've had many, many desperate pleas for financial help with rent, food, childcare, utilities and emergency expenses.
- LONGER SHELTER STAYS: Families are staying 35% more nights because they can't afford to leave. Staff have set up a free clothing "store" in the shelter basement to help clients who come to us with nothing but the clothes on their back.

# CVIC faces funding gap

The pandemic has created a gap of over \$200,000 toward our fundraising goals as we had to cancel special events and incurred costs to provide telehealth services and meet crisis needs. Even some of our faithful supporters have fallen on hard times, unable to stay current on their pledges. If you are in a position to give more this year, please consider helping to bridge the gap.

## EVA & HER MOM



# A message to you, our CVIC supporters: 'I don't have words to describe what you've done for our family.'

Eva and her mom couldn't live with Eva's dad anymore because he would hurt her mom. But Eva missed her dad and wanted to see him, even though it was stressful when they'd meet to exchange her.

"In the past when we didn't have a neutral location, there was a constant traumatic experience," sometimes ending up with "me being yelled at, threatened or assaulted," Eva's mom said. And Eva would "chew her nails to the point they would bleed." Now at CVIC, "she readily gets out of the vehicle, she's happy, she's skipping, she's jumping."

And that means everything. "It very much has reduced a lot of anxiety and fear,

and I always know when I go there, that it's a safe place," Eva's mom said. Eva's exchange between parents is monitored, with no contact at all between Eva's mom and dad.

"I never feel uncomfortable," Eva's mom said. "That is a huge thing that touches my heart because it's not often that I have that, that we have that support as a family."

"The people who support these services, to allow it to be at no cost, should feel far beyond special," she said. "Thank you from the bottom of my heart. I don't have words to describe what you've done for our family."

Many families like Eva and her mom need supervised child exchanges to stay safe.

# The difference one call can make: safety & a future 'Thank you for helping me leave.'

Before the officers took her husband away after strangling her in front of her children, they gave her CVIC's number and told her, "Call them. Call them now."

"I was so scared," Mary said. "My husband had told me, 'I'll kill you; I'll take these kids; you'll never make it without me.' I was so scared to call because I didn't think they could help me. But this person I talked to at CVIC said, 'We'll get you out tonight. What do you need right now?'"

That call changed her life. CVIC helped her with a protection order, accompanied her to court and provided legal representation in her divorce, financial assistance with a

deposit for her own apartment, and therapy for her, and soon for her kids, to "deal with the scars left on them" from the abuse.

"I owe everything to CVIC because I would never have been able to do this on my own," she said. "They really helped me realize my worth, and that drove me to keep achieving. Now I feel like a survivor. I'm not a victim at all—I'm a survivor 100 percent." And she's nearly completed a doctorate degree through it all!

To you, our supporters, Mary said, "I'm so grateful and thankful. Thank you for helping me leave."

Now at shelter, Jack said it's like the window is open, the sun is out, and he is happy.

#### Thanks to you, 8 year old feels safe for first time

Jack's dad made him scared and confused, yet he longed for his approval more than anything. No matter how hard he tried not to be a "sissy" or a "momma's boy," he couldn't make his dad proud. Jack felt so frustrated, he wanted to pound his fists against something. Like his dad did, against the walls and against his mom.

Then one day, Jack's dad pounded his fists on Jack's body, too, and his mom said they had to stay at a shelter. But Jack didn't know what that was or if he'd like it there.

"When he first got to shelter, he was very angry, yelling at his mom and kicking his siblings," Kelsey, CVIC's family advocate, said. "When I used art to teach the kids healthy coping skills, his pictures were always very dark and angry."

But it didn't take long for Jack to realize that the shelter offered something he'd never had before: *safety*. The calm, safe environment seemed to transform him, and he began to learn healthy ways to deal with his anger. He now knows the way his dad was behaving isn't the way a father should act.

"I have seen such a change in him. He is happy and laughing and trying his best to control his anger in a healthy way," Kelsey said. "His imagination is back and he can be a kid again!"

So many other kids are now in Jack's shoes, scared and confused, in desperate need of safety.

# Why I give

Diane Knauf has seen the impact of community violence from multiple lenses. #### Nelson honored with 2020 Peacemaker Award

Grand Forks Police Department Chief Mark Nelson has been named the winner of CVIC's 2020 Peacemaker Award for his outstanding commitment to ending violence in Greater Grand Forks. Nelson is a key stakeholder supporting implementation of CVIC programs that improve officer responses to domestic and sexual violence.

Other nominees were Grand Forks County Sheriff Andrew Schneider, Manvel Public Schools Principal Melissa Hiltner and UND Associate Professor Kara Wettersten.

#### Strong police-CVIC partnership

"There's commitment from day one (in the department) to understanding how domestic violence impacts our community and how it's not a standalone issue. Building that understanding has made us better as a department," Nelson said. At national meetings with peers, the strong collaboration between CVIC and the department is often discussed, he said, adding, "I humbly accept this on behalf of my staff."

#### Virtual rally raises awareness

Nelson's recognition was announced Oct. 20 at CVIC at UND's Take Back the Night rally, part of the Domestic Violence Awareness Month activities. This year's virtual event may be seen at cviconline.org.

"Leadership matters and Chief Nelson's leadership and his team's commitment to our mission are unmatched," CVIC President/CEO Coiya Tompkins said. "We're grateful for the expertise of the chief and his team, which enables more victims to reach vital safety and healing services sooner."

#### Community acts to prevent violence

Gate City Bank and Altru Health System are key partners in advancing Green Dot, a bystander intervention program. Now, through training, more people are making choices (green dots) to make our community safer:

- "I talked to a friend about the warning signs of an abusive relationship."
- "I had a conversation with my family about violence prevention."
- "I saw a man pushing drinks on an intoxicated woman so I stepped in and got her water and made sure she had a safe ride home."

#### CVIC boosts trauma response in GGF

With generous grant funding, CVIC hosted several trainings on evidencebased therapies for over 30 local professionals this year to increase our community's capacity to serve people experiencing trauma and reduce its long-term impact, as part of our Safer Tomorrows Project to end local violence

Two trainings focused on school interventions, including one for elementary students exposed to traumatic events, meeting a great need for more services for children.

Clinicians were overwhelmingly positive, saying, "I am very thankful for this opportunity and excited to start providing this evidence-based intervention for kids who might not otherwise receive it."
