Dear Friend,

You don't have to spend much time with our team to learn about the stark statistics that keep us up at night. They represent human beings and a second generation impacted by violence. They are numbers CVIC and its friends simply can't accept.

As overwhelming as statistics can be, we regularly track key data, analyze trends and ask tough questions to determine best approaches to end interpersonal violence. Thankfully, we are never alone on this journey and the resilient individuals, strong families and thriving communities that motivate us are not either. You, our friends, partners and donors, make it your business to make a difference.

Yet, after 41 years of service to Grand Forks County, our work is far from complete. We monitor the numbers that are hard to absorb because they represent people we care about and too many times, lives are at stake. The harsh reality is that someone you know has likely been impacted by interpersonal violence, whether you know it or not.

Last year, we served four percent more clients than the prior year. In the first half of 2021 we've reached more victims of violence than the first half of last year. All tracking aside, it's those we're not reaching who also keep us up at night.

Ending interpersonal violence is everyone's business. Violence doesn't discriminate. It can impact anyone.

CVIC and its partners provide round-the-clock support, regardless of income level, gender, sexual orientation or age.


In this report we recognize the hundreds of individuals and businesses who supported CVIC's work last year, making it their business to help children heal from trauma, adults find safety and support during times of crisis, and youth learn how to develop healthy relationships.

Tanya's Triumph



*"Without CVIC
I'm scared I
wouldn't be here."*

Happy.

Confident. Independent.

Graduate. Homeowner.

Safe.

There were many times Tanya doubted she'd be any of those things, much less all of them. Many times, she wasn't sure she'd live.

She was afraid. Insecure. Isolated. Homeless.

For more than 20 years Tanya endured physical and emotional abuse that started after her first child was born. "When it got bad, he would torture and beat me for days," she said. Killing her was a threat her then-husband often used. "It kept me quiet, and it kept me in the marriage because I didn't want to die. I didn't want my kids to wake up and not have their mom."

He isolated her from her family and friends, convincing her they didn't care. Others distanced themselves, unsure what to say or how to help. Her family, which grew to six children, was homeless many times. "For so many years he made me feel worthless, like I couldn't do anything without him," she said. "The manipulation was nonstop."

Determined to Live

With unimaginable strength and faith, she left one day about five years ago. And she's not looking back. Because even starting with nothing, life was better.

"At times it was hard, knowing I was alone with six kids. The unknown is scary. But it was easy, too, because I knew I wouldn't have to worry about being hurt. After 20 years of being scared, I was just done," she said.

Not Alone

Tanya says when she found CVIC, it was a turning point for her. "I finally felt like I had people behind me and I didn't worry about anyone taking it away. You made me realize I was strong enough to do this."



She is grateful for the resources that have been available, including therapy for her and her children, legal help to get her divorce, transitional housing, financial help, and emotional support. "CVIC never made me feel like I was stupid. I have amazing friends, but they haven't been where I've been. Sometimes I just needed someone to listen."

Pay it Forward

Last year, Tanya unlocked the door to what will soon become her own home. This summer, she graduates from college with her associate's degree and will be back in school this fall, pursuing her degree in social work.

"I hate to see people hurting. I've been there. I hope I can help people who have been in situations like I have, thinking they're stuck," she said.

She's grateful that CVIC donors have been behind her, too, supporting her journey to independence. Despite working two to three jobs (while going to school and raising six kids), without resources like an education fund to help offset school costs, or financial assistance to help with rent, food, and utilities, Tanya's not sure she'd be this far.

"I can't believe someone can be that generous. It's so selfless. I have a fresh start because of all the support and help."

One day, Tanya wants to pay it forward. "I would love to be in a place where I could give this (home) to someone else in a situation like mine so they can have the same feeling of finally being safe."

Families are comforted and safe

Bonnie* had been to our shelter before. This time, when she fled from an emotionally and physically abusive partner, she and her children were relieved to be surrounded by familiar faces and open arms at Mary's Place Shelter.

We provided them the stability and sense of safety they needed most. Not only did staff provide emotional support, they provided crisis intervention, education and employment assistance, and helped Bonnie find safe housing.

Our family advocate took extra care of Bonnie's children with activities that helped them with coping skills, learn about healthy relationships, and manage their stress. One day Bonnie marveled as she watched her daughter and our advocate together: "She must really trust you. She doesn't normally get so close to people."

Therapies help youth heal from trauma

Life hasn't been easy for Seth*. He's seen volatile bouts of domestic violence at home, has been neglected, and was sexually assaulted. The resulting trauma he carries with him is unimaginable.

He received counseling at other places but never felt a connection and at times, felt like his confidentiality had been violated. As a result, he didn't trust counselors and resisted getting the help he so desperately needed. Despite his lack of trust in the therapy process by this point, Seth agreed to try once more.

With hope and encouragement from his supportive family, Seth is now beginning to turn the corner. He is regularly attending sessions and actively participating with his therapist, a huge step for this brave young man who has endured too much in his young life.

He is benefiting from the care and understanding his CVIC youth therapist provides and is regaining trust, an important step in his long-term healing. Our evidence-based, trauma-informed therapies are now helping Seth recover from his trauma and begin to thrive.

CVIC educates thousands, including future medical professionals

Every year since 2007, CVIC's prevention team spends a week at UND's School of Medicine & Health Sciences, training future doctors about dynamics of domestic and sexual violence, helping them learn more about how to support patients they will encounter during their career. Since the partnership started, we have trained more than 650 people, many of whom are practicing throughout the country.

Recently, one of the participants made a first donation to CVIC, telling us, "I work at UND's medical school. Every year, your organization spends time with our medical students to help them better understand the realities of how abuse (in all of its forms) is a community issue. I have found that your organization not only makes a difference in the lives of your clients, but in the lives of these future doctors. I cannot express how much I respect the dedication and care that your organization and your staff give to those individuals who are most vulnerable."


