Make a one-time gift or give over time in a way that works for you. Gifts can be made by cash, check, or credit card, with the option to set up automatic recurring giving.

Make Your Gift Go Further



Appreciated Stock

Give stock that has increased in value to potentially avoid capital gains taxes and receive a full charitable deduction—often allowing you to give more than you would with cash.



Donor-Advised Funds

Many of our supporters give through a Donor-Advised Fund (DAF)—a flexible and tax-efficient way to support CVIC and the people we serve. If you have a DAF, you can recommend a grant to CVIC at any time.

Employer Matching Gifts

You may be able to double your impact through an employer matching gift. Many companies match donations made by employees, retirees, and even board members. Check with your payroll department to see if your gift qualifies.



IRA Qualified Charitable Distribution (QCD)

If you are age 70½ or older, you can request your IRA custodian to transfer funds directly from your IRA to CVIC—often tax-free.



Give Through the Community Foundation

You can also support CVIC through funds held at the Community Foundation of Grand Forks, East Grand Forks & Region, including donor-advised, designated, field-of-interest and endowment funds.



Endowment & Legacy Giving



Endowment Gifts

Support CVIC with an endowment gift of cash, stocks, or other appreciated assets.

Create a lasting legacy with a CVIC endowment and receive a 40% North Dakota state tax credit (up to \$10,000) for contributions of \$5,000 or more from individuals and businesses. Couples filing jointly may receive up to \$20,000 in tax credits each year.



Honor or Remember Someone Special

Make a tribute gift in honor or memory of someone meaningful. We will notify the individual or their family of your gift.



Leave a Legacy

Plan a gift that reflects your values and supports future generations. Options include:

- Naming CVIC as a beneficiary in your will, retirement account, or life insurance
- Establishing a charitable gift annuity or trust
